

FUND OBJECTIVE


To provide long term capital growth from an actively managed portfolio comprising equities, bonds, listed property and cash – both local and foreign. To achieve long term capital growth, the fund will have a bias towards equity (which typically offers the best returns over the long run), but no guidelines have been set for maximum and minimum exposures to any one asset class. Our benchmark is 60% equities, 20% bonds and 20% cash with each category split equally between local and international assets. The fund is classified with ASISA as a Worldwide - Multi Asset - Flexible fund.

## FUND COMMENTARY - JUNE 2024

The Flagship IP Worldwide Flexible Fund returned -1.5% vs its composite benchmark which was up 0.7% (both in ZAR), as US markets showed no signs of slowing down, while returns from other international markets were more muted. In addition, with 50% of the fund's benchmark linked to South African bond and equity markets, the domestic market's strong post-election rally added to the fund's relative under-performance (as we remain underweight South Africa).

The biggest contributors for the month were the fund's JSE Financials and JSE Midcap index holdings, while the main detractors were Trip.com and Rheinmetall.

As required by legislation, we confirm that the fund has adhered to its policy objective and strategy.

#### **MARKET COMMENTARY**

Global equity markets delivered vastly different results to close out the first Headlines in June were dominated by politics. A major political swing was half of the year. In the US, all rooms were sea-facing as the S&P 500 returned 3.6% for the month, largely driven by constituents that also form part of the tech-heavy Nasdaq composite which returned 6% for the month. Year-to-date (YTD), the S&P 500 has now returned 15.3%, while the Nasdaq composite returned 18.6%. In the shadow of this tech-driven performance, we find the small cap Russell 2000 index, which was down 0.9% for the month, and is barely in the green, YTD. In the UK, the FTSE 100 dropped 1.7% for the month, while the Euro Stoxx 50 declined by almost 3%. YTD, both indices have returned in the region of 7%. In the East, the Hang Seng Index continues to be volatile. After a strong recovery the previous month, June saw it giving back 1.1%, which now puts the YTD performance at 6.2%.

Despite the robust stock market performance in the US, there are certainly some warning lights flickering. One of these is the weak breadth of the market rally. YTD, Nvidia (+166%) accounted for 6% of the S&P 500's 15% return, with the S&P 499 returned only 9%. Remove the rest of the Magnificent 7, and the return of the S&P 493 drops to 6% YTD. The second concern is consumer weakness - retail sales came in softer than expected in May, confirmed by profit warnings from several consumer driven sectors. Footwear and apparel giant Nike a clear example of this, falling 20% after providing weak guidance.

confirmed in the UK, as the Conservative Party lost to Labour, after 14 years in power. In France, after a dominant showing by Marine le Pen's "Far right" National Rally in the first round of elections, circumstances changed dramatically in the second round, with a swing back to the centre and far left, leaving no party with an overall majority. In the US, a Republican (i.e., Donald Trump) victory is now looking likely after Joe Biden performed terribly in the first presidential debate. This raised the alarm in Democratic circles, as voters now believe his cognitive state is clearly not fit for someone occupying the most powerful office in the world.

Locally, news flow was dominated by the bickering and bumping of heads between the DA and the ANC as President Ramaphosa tried to get his cabinet for the Government of National Unity up and running. After much debate, and the DA threatening to pull out of the agreement, a deal was finally struck which led to optimism in local markets, evident in the double-upgrade South Africa received from JP Morgan. Responding to improved sentiment, the JSE Allshare Index staged an impressive rally, returning 4.1% over the month, while the JSE Financials index surged an eye-popping 17.5%. This strong performance, if not given back, should lead to increased weighting in emerging market indices, which should lead to increased flows from international investors.

#### **Investment Policy**

The Flagship IP Worldwide Flexible Fund is a Worldwide-Asset Allocation portfolio in the Flexible Portfolio Sector. The primary objective of the Flagship IP Worldwide Flexible Fund is to offer medium to longterm capital growth. The portfolio will invest in a flexible combination of investments in equity, bond, money or property markets to maximise total returns over the long term. The portfolio will be actively managed with exposure to various asset classes being varied to reflect changing economic and market circumstances, in order to maximise returns for investors.

In order to achieve its objective, the investments normally included in the Flagship IP Worldwide Flexible Fund will comprise a combination of local and foreign securities, exchange securities, stock including loan stock, financially sound listed property investments and participatory interests in portfolios of collective investment schemes in property shares, assets in liquid form and any other securities which are considered consistent with the portfolio's primary objective and the Act or the Registrar may from time to time allow, all to be acquired at fair market value. To the extent permitted by legislation, the fund may use exchange traded funds and financial instruments to implement specific investment views.

#### **TER and Transaction Costs**

From 1 April 2021 to 31 March 2024 2.23% of the value of the fund was incurred as expenses relating to the administration of the fund. 0.44% of the value of the fund was incurred as costs relating to the buying and selling of the assets underlying the fund. Therefore, 2.67% of the value of the fund was incurred as costs relating to the investment of the fund. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the fund and impacts fund returns.
